



**By signing this document I understand that I waive certain legal rights, including the right to sue the Minnesota 3Gun Group (hereinafter referred to as "MN3GG") and its host facility at the date of the event, and its officers and agents.**

**EXPRESS ASSUMPTION OF THE RISKS ASSOCIATED WITH HANDLING, CARRYING, AND SHOOTING FIREARMS AND AMMUNITION**

The undersigned participant (the "undersigned" or "I") do hereby affirm and acknowledge that I am aware of the inherent hazards and risks associated with firearms and live ammunition and their use and handling. I fully understand that these risks can lead to severe injury to myself or others and even death. Despite the potential hazards and dangers associated with firearms and live ammunition, and the participation in recreational, educational and sporting use of firearms, or while observing others engaged in these activities, I wish to engage in these and other firearms related activities at the MN3GG event and on the premises of its host facility at the date of the event. I freely accept and expressly assume all risks, dangers, and hazards that may arise from the use of firearms by myself and others at the MN3GG event and on the premises of its host facility at the date of the event and which could result in personal injury, death and property damage to myself or others.

**RELEASE OF LIABILITY, AGREEMENT TO WAIVE CLAIMS, EXPRESS ASSUMPTION OF RISKS, AND INDEMNITY AGREEMENT**

In consideration for being allowed to participate in or observe any firearms related activity at the MN3GG event and on the premises of its host facility at the date of the event, being permitted to use the MN3GG and its host facility's facilities and equipment, being permitted to be present on any real estate owned, leased or used by the MN3GG and its host facility at the date of the event, and being permitted to be a member or guest, I hereby agree as follows:

1. TO WAIVE AND RELEASE ANY AND ALL CLAIMS, DIRECT OR INDIRECT, AND ALL RIGHTS OF DAMAGES RECOVERY THAT I MAY HAVE NOW OR IN THE FUTURE AGAINST the MN3GG event and its host facility at the date of the event, AND ITS DIRECTORS, OFFICERS, AGENTS, EMPLOYEES, REPRESENTATIVES AND VOLUNTEERS (HEREINAFTER REFERRED TO AS "RELEASEES").

2. TO RELEASE THE RELEASEES, FROM ALL LIABILITY AND RESPONSIBILITY, WHATSOEVER, FOR ANY CLAIM OR CAUSE OF ACTION THAT I, MY ESTATE, HEIRS, EXECUTORS OR ASSIGNS MAY HAVE, INCLUDING, BUT NOT LIMITED TO NEGLIGENCE, PERSONAL INJURY, PROPERTY DAMAGE, IMPAIRMENT, LOST WAGES, WRONGFUL DEATH AND ALL POSSIBLE CLAIMS ARISING FROM FIREARMS USE OR OTHERWISE OCCURRING AT THE MN3GG EVENT ON THE PREMISES OF ITS HOST FACILITY, WHETHER CAUSED BY THE ACTIVE OR PASSIVE NEGLIGENCE OF THE RELEASEES OR OTHERWISE. BY EXECUTING THIS DOCUMENT, I AGREE TO RELEASE AND HOLD THE RELEASEES HARMLESS FOR ANY INJURY OR DEATH WHICH MAY OCCUR TO ME OR OTHERS WITHOUT REGARD TO WHETHER THE

INJURY OR DEATH OCCURS WHILE ACTUALLY ENGAGED IN ANY FIREARMS ACTIVITIES.

3. To indemnify and defend Releasees from any suits and all claims and expenses, including attorney fees and costs of defense, arising from any claims resulting from my negligence or conduct. I will also indemnify and defend Releasees from any suits and all claims arising from the negligence or conduct of persons who I bring to MN3GG and its host facility as my guest.

4. To abide by any and all safety rules and range procedures in effect by the MN3GG and its host facility at the date of the event. I acknowledge that it is my duty to know and understand these rules. I understand that a violation of safety rules may result in my immediate ejection from MN3GG event and it host facility's premises.

5. By entering into this Agreement, I am not relying on any oral or written representations or statements made by the Releasees, other than what is set forth in this Agreement. I further agree that this Agreement shall be governed by and interpreted in accordance with the laws of Minnesota. I intend that the above waiver and release be as broad and inclusive as permitted by law, and if any portion is adjudged invalid or illegal, the remaining portions shall continue in full force.

6. By entering into this Agreement, I agree that the above waiver and release shall be active and effective in all of the MN3GG events in the calendar year when I entered into this Agreement.

**I HEREBY DECLARE I AM COMPETENT TO SIGN THIS AGREEMENT. I HAVE READ THIS AGREEMENT, I UNDERSTAND IT, I VOLUNTARILY SIGN THIS AGREEMENT, AND I AGREE TO BE BOUND BY IT. IF PARTICIPANT IS A MINOR, THE PARENT OR GUARDIAN OF SAID MINOR SHALL BE REQUIRED TO EXECUTE THIS AGREEMENT.**
